Summary: Bury Council is seeking to appoint a suitably qualified contractor to carry out drainage works and minor highway maintenance across the borough. Following evaluation of the submitted tenders for Highway Drainage and Minor Works 2024/25-25/26, it is recommended that the lowest evaluated score of 98%, submitted by Argyle (North West) Construction Ltd. of The Quad, 47 Gibfield Park Avenue, Atherton, Manchester M46 0SY is accepted as providing best overall value to the authority. The contract is based on a schedule of rates and does not have a fixed price. The amount the Council decides to pass through the contract will be based on meeting minimum safety requirements on the highway and available budgets. Expenditure through this contract is anticipated to be circa £240,000 per annum.
