### **RESOLVED /-**

1. That the current position relating to the Greater Manchester Ecology Unit (GMEU), Waste and Minerals and Flood and Water management be noted.
2. That it be confirmed that funding is available for the Greater Manchester Archaeological Service unit for 2 years from April 2026 and it be requested that Salford City Council extend the existing contract with Salford University to host the Greater Manchester Archaeology Unit and associated AGMA budget from April 2026 until April 2028.
3. That a review take place of the funding arrangements for the 3 Planning Advisory Units and Flood Risk Co-Ordinator Post (1FTE) and a further report be brought back with proposed reforms in September to feed into the budget setting process for April 2026.
