The Children's Trust is part of the Team Bury structure, governance is via the Health & Wellbeing Board. The Children & Young People's Plan forms part of the Team Bury governance arrangements.

2. Introduction / Background

The requirement for partners to work together to improve the lives of children and young people through Children's Trusts is set out in the Children Act 2004, Section 10 'Duty to Cooperate'.

Children & Young People's Plan 2015-18 sets out Bury Children's Trust working arrangements, its Ambitions for children and young people, and the Priorities which partners will work together to address over the next 3 years.

The Children's Trust Board sets and drives the Children & Young People's Plan and is supported by the Children's Trust Operational Group. The Children's Trust Network involves the wider workforce in developing and delivering the Priorities and the Participation Strategy ensures the active participation of children and young people at all levels of the work.

Aligned to the CYPP 2015-18 are 2 supporting documents, the Early Help Strategy and the Strategy & Guidance for the Active Participation of Children & Young People. These Strategies are not being brought to the H&WB today, but are noted here for information.

3. key issues for the Board to Consider

The CYPP sets out overarching Ambitions which encapsulate the vision of the Children's Trust for all children and young people, ie, Right Help Right Time and Life Ready. Over the next 3 years, the Children's Trust Priorities will be:

 Children and Young People will have access to early help: right help, right time, right person

- Developing Resilience and Improving Emotional Health & Wellbeing in children and young people
- Preventing Alcohol and Substance Misuse

The focus of the Children's Trust is on services working together more effectively so that problems are identified early and the necessary support in place when and where it is needed. The Health & Wellbeing Board has an oversight of many areas of work and developments that can help to meet the Priorities and is asked to have this in mind, especially in the development of new initiatives which could be joined up with existing work through the Children's Trust.

The Children's Trust is committed to a culture of participation by children and young people, recognising and building on their strengths, and this is reflected in its approach to developing and delivering the CYPP. The Health & Wellbeing Board is asked to assist the Trust Board in developing a participation culture and recommends that the Participation Strategy is brought to a future H&WB Board meeting.

Health & Wellbeing Board is asked to approve and sign off the Children & Young People's Plan.

Children's Trust Board to provide update reports to Health & Wellbeing Board at agreed intervals (six-monthly).

Children's Trust Board brings the Participation Strategy to a future Health & Wellbeing Board for information and discussion.
