S.737 MINUTES OF THE LAST MEETING

S.739 DECLARATIONS OF INTEREST

S.740 PUBLIC QUESTION TIME

Councillor Walker asked for the outcome of two complaints made against him to be recorded. The complaints had been referred by the Standards Assessment Sub-Committee for investigation. The investigator concluded that Councillor Walker had not breached the Code of Conduct and these findings had been confirmed by the Standards Consideration Sub-Committee.

S.741 MONITORING OFFICER'S PROTOCOL

A report was submitted which set out proposals for minor amendments to the Monitoring Officer's Protocol, some of which were necessary following responsibilities placed upon the Monitoring Officer by the Localism Act 2011.

Delegated decision:

That the Summary of main Monitoring Officer's functions as set out at Appendix 1 to the report be approved.

S.742 REVISIONS TO THE CODE OF CONDUCT

A report of the Monitoring Officer was submitted which recommended, in light of recent complaints, the re-introduction into the Code of a requirement for members to behave with respect towards others.

Recommendation to Council:

Under Section 3 of the Code of Conduct (General Obligations), the following provision be included:-

- "3.1 You must not:.....
- (e) Behave in a way that a reasonable person would regard as disrespectful."

S.743 GUIDANCE FOR COUNCILLORS ON USE OF COUNCIL RESOURCES

A report was submitted which set out draft guidance for Councillors the use of Council resources.

Recommendation to Council:

That the draft guidance be approved for issue to councillors and inclusion in the Constitution subject to amendment/clarification on the following:-

- Page 1 Clarity on resources in the public domain;
- Page 1 Use by Members of IT facilities;
- Page 3 Clarity on publicity following the publication of an election notice.

S.744 REPORTING OF SUB-COMMITTEE DECISIONS

A report was submitted which set out how the decisions of Standards Sub-Committees would be recorded so that there was a public record of the proceedings as well as a detailed Decision Notice.

S.745 "ERRANT COUNCILLORS AND THE NEW STANDARDS REGIME"

A paper by Clive Sheldon QC was submitted which highlighted cases dealt with under the new Standards regime and some of the deficiencies inherent in the new system. It also highlighted challenges posed by social media.
